Mount clean and well brushed with hooves picked out and showing farrier care. Eyes, nose, lips, and dock wiped off. Tack to be safe and clean (properly adjusted with assistance if necessary), with attention to stitching, girth, and stirrups. No obvious jockeys or heavy dust. Groom and tack up with assistance if necessary. Name and locate 10 saddle parts and 5 bridle parts.
